



SAYREVILLE RECREATION BURKES PARK SUMMER CAMP COUNSELOR IN TRAINING (CIT) PROGRAM DESCRIPTION

GENERAL DESCRIPTION

The Counselor In Training (CIT) program is open to anyone entering ages 13 and 14 at the start of camp. The CIT program provides training for future camp counselors. Participants who successfully complete the CIT program receive a certificate.

The goal of the program is to help CITs develop leadership skills, safety skills, learn about child development and camp's role in childhood, and become a positive role model. CITs will be assigned an experienced counselor as a mentor throughout the program.

CITs are encouraged to apply for a position in the future and are given preference. However, completion of the CIT program does not guarantee employment.

DATES / TIMES / LOCATIONS

The CIT program is held during camp: Mondays through Thursdays, July 1 -August 8, 2024 from 8:30am to 12:00pm each day. The program is held in conjunction with Burkes Park Summer Camp.

SELECTION

Participants in the CIT program are selected through an application and interview process. Please refer to the application for the deadline to apply. CIT positions are limited and the number of positions may vary year to year.

Upon selection, CITs will be required to complete their registration on the Sayreville Recreation website and submit the program registration fee, which is the same as the camper registration fee.

CIT RESPONSIBILITIES WITH CAMPERS

A CIT will be subject to the same code of conduct and policies as regular program and camp staff.

Under the supervision of a head counselor, CITs will:

- Recognize that as a CIT they are a role model to younger campers
- Make the camp a fun and safe place
- Help provide a safe and supportive atmosphere for all participants
- Help participants resolve conflicts
- Assist camp staff with organization and implementation of camp activities
- Maintain a positive and professional attitude at all times
